Introduction

These training courses advance your knowledge and research skills in the field of sexual and reproductive health.

The program is designed to address a wide range of contemporary reproductive and sexual health problems and is especially relevant for developing countries. Its development is the result of collaboration between experts from World Health Organization (WHO), GFMER, and other national and international health training and research institutes.

Participants make direct contact with WHO (Department of Reproductive Health & Research and Department of Child and Adolescent Health) and other research institutes. This enhances their professional network and offers new opportunities for their career.

Course period

The study time required for each course is 8 weeks.

Study materials

To compensate for live meetings and instructions, the reading and writing requirements in online courses are typically more substantive than in traditional courses. The advantage is that you not only acquire knowledge through course materials, through your personal time management, but also learn

how to communicate in an online learning environment. In order to complete the courses, you need self-discipline and time management skills.

Presentations

Each course contains a number of presentations and other audio-visual materials. They are available on the related sites and can be accessed whenever the participant wishes.

The presentations and audio-visual materials can also be accessed by smartphone and tablets. They are also available in PDF format.

Integrated key readings

We have selected reference documents from a wide range of sources. You can find these required readings by following the links in each course. We also provide suggestions for further reading.

Study support

The course coordinators have specific research interests and actively collaborate in the management of the courses. They are responsible for the academic quality of the course materials and they are involved in course development, teaching, and assessment. A personal coach is assigned to each participant. The role of personal coach is to facilitate the learning process to the participants, review her /his assignment and other paper works. Personal coach is the primary contact of the participant.

With extensive international experience in research and postgraduate education, specialist tutors support the lecturers by offering technical assistance to the participants.

During the time allocated for each course, participants have the opportunity to get training from tutors and course organizers.

Assignments

Below are the assignment requirements for the different courses:

Adolescent sexual and reproductive health module

This module is comprised of 8 presentations (also called modules). For each presentation /module, participants should:

- Go through the slides and talking points.
- Read the 1-3 accompanying documents.
- Do the short (1-2 pages) assignment, after going through the slide sets and documents.
- Answer to the multiple-choice questions and complete the end of course assignment.

For the end of course assignment, participants are required to provide information on the overall situation in their countries in terms of adolescent sexual and reproductive health. The analysis should include information about the current country strategies, existing health services designed for adolescents and existing barriers and challenges. The assignment should be based on a literature search and, if relevant, professional experiences of the course participant. It should not exceed 7 pages.

Research methodology and research protocol development

For each module, participants must:

- Study the slides and talking points.
- Read all accompanying documents.
- Answer to the multiple-choice questions.
- Complete the short assignment or interactive exercise, after going through the slide set and documents.

At the end of the course, participants are required to produce a research protocol using the knowledge acquired from this course. The topic chosen for the research should be relevant to the participant's professional occupation and based on a real issue in his/her country. Students will receive advice from their personal coach, course coordinators and concerned teachers on their research project.

Sexually transmitted infections, HIV/AIDS

For each module, participants must:

- Study the slides and talking points.
- Read all accompanying documents.
- Answer to the multiple-choice questions and complete the short assignment, after going through the slide set and documents.

In the paperwork assignment, participants should provide information on the overall situation in their countries in terms of sexually transmitted infections. The analysis should include information about the occurrence of STIs and HIV/AIDS (prevalence, incidence and health services data), current country strategies, prevention measures, care services and existing barriers and challenges. The assignment should be based on a literature search and, if relevant, professional experiences of the course participant. It should not exceed 7 pages.

Family planning module

For each module, participants must:

- Study the slides and talking points.
- Read all accompanying documents.
- Answer to the multiple-choice questions and complete the short assignment, after going through the slide set and documents.

For the written assignment, participants will provide information on the overall situation of Family Planning in their countries in terms of prevalence, relevant health services data, current country strategies, care services and existing barriers and challenges. The assignment should be based on a literature search and, if relevant, professional experiences of the course participant. It should not exceed 7 pages.

Note:

Timely completion of assignment is taken into consideration for the final evaluation and certification of participants.

Final evaluation and certification

In order to validate each course and obtain the certificate, participants are required to:

- Successfully answer to the multiple-choice questions. To provide the correct answers to the multiple-choice questions, participants need to study the module presentations and documents. The pass mark is 75%.
- 2. Complete the written assignments which should be based on a literature search and relevant professional experiences of the course participant. We will provide specific guide and instructions for paperwork assignment.

Participant's ID

Each participant will be assigned a unique number as a participant's ID. Participants are asked to use this ID in all communications with GFMER.

Assignment's code

Each assignment will get a unique number as an assignment's code. When participants submit their assignments, both their participant's and the assignment's code should be used as part of the file name and in the content. An assignment template will be provided during the course.

The online learning environment

List of participants

A list of names of all participants and their affiliations will be published on the course web page on GFMER website.

Online communication

Online communication not only gives you administrative and technical support, but also offers the opportunity to broaden your education. Course-specific discussion rooms offer you the chance to bring both academic and non-academic issues under the attention of course coordinators, coaches as well as other participants. You will find electronic documentation to download, links to other relevant resources, and information about important events. The diversity within the community of participants and the network facilitated by the program provides a wonderful opportunity to learn from and share experiences with people from different countries.

Google Groups
